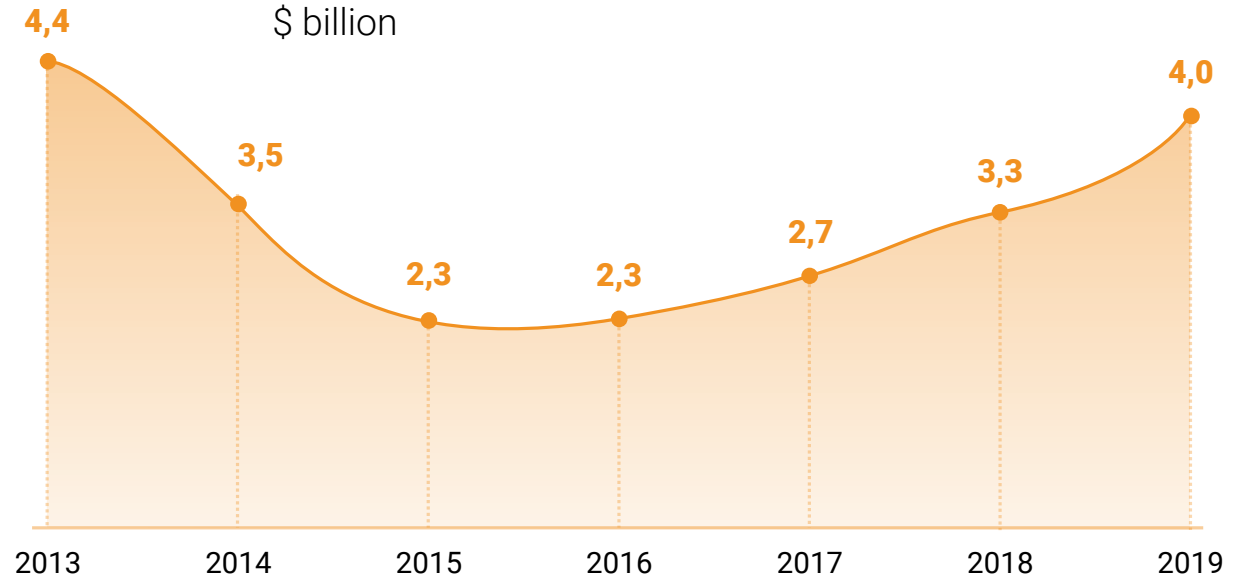
in Ukraine's Pharma Industry

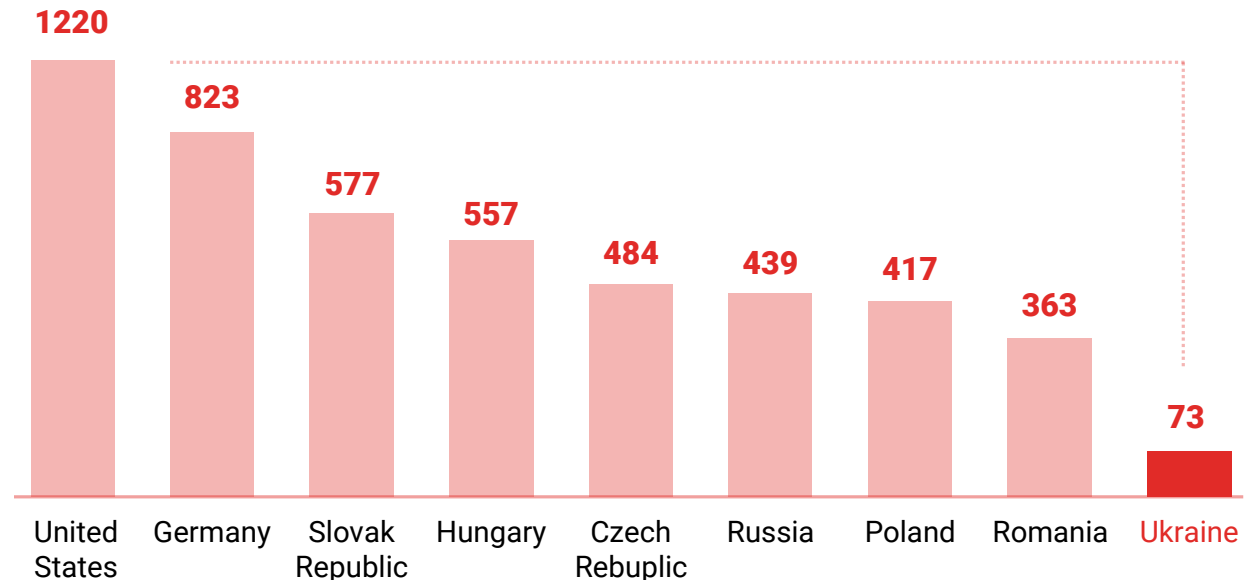
CONSUMPTION GAP vs. PEER COUNTRIES in Ukraine's Pharma Industry
