

The pharmaceutical sector in Ukraine has been experiencing significant growth in recent years. The industry is composed of both local and international companies.


In terms of local production, Ukraine has a significant pharmaceutical manufacturing industry. The local industry focuses primarily on the production of generic drugs, with most of the production being consumed domestically.



The biggest share in the structure of consumption is taken by anti-inflammatory and antirheumatic drugs. The largest increase in consumption in 2022 was displayed in blood pressure-lowering drugs share.

According to the results of 2022, the companies "Farmak", "Darnytsia" and "Acino" became the leaders in terms of the volume of pharmacy sales of drugs.

The war had a different effect on the development of companies: some show growth, while others, on the contrary, decline. The war factor affects the development of manufacturers to a large extent. Decrease in sales experienced Farmak (-14.5%), Sanofi (-14.5%), Arterium (-6%).



STATE SUPPORT FOR INDUSTRIAL PARKS

- 10-year CIT exemption
- VAT, import duties exemption for new equipment
- full or partial interest rates compensation on loans
- financing for arrangement of industrial parks, etc.



STATE SUPPORT FOR PROJECTS WITH SIGNIFICANT INVESTMENTS (20+ MLN EUR)

up to 30% CAPEX compensation in forms of:

- 5-year CIT exemption
- VAT, import duties exemption for new equipment
- land tax exemption, etc.

60 industrial parks which are officially registered as of January 2023 in Ukraine may utilize the benefits of described incentives

As of February 2022 28 projects (2+ bln EUR in investments in total) were seeking to obtain the state support

As of January 2023 8 projects (1.3+ bln EUR in investments in total) are on the final stage on application submission
