

The volume of iron ore extraction exceeds that of Potassium by 64 times



Major EU suppliers of CRMs in 2023






Industrial sales in the mining industry, UAH bln



Industrial production index of the extractive industry, % y-o-y










FDI snapshot


War risk insurance and government policies aimed at improving the investment climate contribute to the growth of the industry






Oil and gas extraction in Ukraine, 1950-2022*










Extraction of iron ore by Ukrainian companies, early 2022, mln t






Amber production in Ukraine, 2023, kg


























Leading EV battery exporting countries, 2020





INVESTMENT INSURANCE







A formalized agreement on the implementation of the investment insurance mechanism for foreign investments: 2022

Annual rate: 2-3%

Insurance period: 10 years

Coverage of the amount of losses: up to 90% Sure Trust Fund: USD 110 mln, goal - USD 330 mln

Law No. 9015 "On Amendments to the Law of Ukraine "On financial mechanisms for stimulating export activity" regarding insurance of investments in Ukraine against military risks": 2023


